Expansion and Improvement of WECA Facilities

- WECA headquarters and apprenticeship programs settled into their new Northern California training facility in the Sacramento region and improvements continue
- Secured major donations to labs, with particular help from our member contractors and industry partners, and completed new VDV/FLS labs at Northern California and San Diego training facilities
- VDV lab gained approval as a BISCI-approved training facility
- Mural depicting work and life of an electrician commissioned and completed

- Numerous state officials and community leaders toured WECA's Northern California (Sacramento Region) training facility

Political Advocacy

- In a big win for apprenticeship, WECA collaborated with both union and openshop apprenticeship programs to preserve RSI (Related Supplemental Instruction) contributions for apprenticeship training and to consolidate program administration under the community colleges while protecting RSI as a categorical program and our existing relations with our LEAs (Local Education Agencies)
- Candidate supported by WECA PAC elected in Central Valley
- Lobbying efforts and political support for Fair and Open Competition regarding Project Labor Agreements (PLA's) significantly increased
- Time extension for which WECA lobbied granted by State of CA for ESL students in taking electrical certification test



- Increased access for members to WECA lobbyist Richard Markuson regarding political agendas/issues that impact them
- 2013 Labor Law Book update released for contractor members
- Construction Trades Compliance Program (CTCP) successful in educating contractors regarding compliance requirements

Association Highlights

- Streamlined and reduced operational expenses
- Access to information for members and students via WECA website improved concurrent with launch of redesigned website
- Improved customer service to our contractors and students and expanded availability
- Increased contractor and industry partner membership in 2013
- Continued superior results in required annual financial audits
- Robust social media presence developed with almost a thousand followers across multiple platforms and dozens of daily interactions with electrical trivia games

Electrical Training Product Launches

- WECA's instructional design team and in-house subject matter experts, (our instructors!), developed and launched a new product line of online, interactive, selfpaced courses, including the courses "Working with Inspectors," "Faultless! Conductor Properties and Circuit Ampacities," and "Sizing Motor Circuits"
- This same team developed and launched a new line of courseware products for electrical training providers; these complete, "teach them out of the box" courseware packages include "Blueprint Reading for Electricians" Parts 1 and 2, "Basic Motor Controls" Parts 1 and 2, and "Communication Skills for Electrical Supervisors"
- WECA's new self-paced online courses and courseware package product lines entered the national market

- · Continue to expand our member benefits and services
- Continue to increase the volume of hands-on labs and competency-based measures in apprenticeship curriculum for VDV, Commercial and Residential programs
- Get Wired! Electrician Trainee and Journeyman courses launched on 2011 code to match State of CA code year adoption which took place in January 2014; 2014 code updates on apprenticeship curriculum and WECA self-paced courses in progress
- Continue to collaborate with new and existing Industry Partners to introduce products and services beneficial to our contractor members
- Continue to pressure legislators and state officials for fair and open competition for our members and their employees
- Additions to WECA's new electrical training product lines along with expanded distribution and partnership for WECA's courseware
- WECEF reinstituting students scolarships and holding a fundraiser crab feed in March 2014
